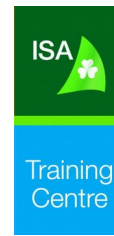

BOOKING

Courses may be booked by payment of course fee or a deposit of €50 per person, non-refundable, before **deadline Friday 27th April 2018**. Balance payable **before Friday 25th May 2018**. There will be a limited number of places on each course, which will be reserved according to booking receipt date.

Courses will only proceed if sufficient bookings have been received and appropriately qualified instructors are available, so it is important that bookings are submitted within the dates specified.

CONDITIONS OF ACCEPTANCE FOR JUNIOR TRAINING

- 1) Applicant must be at least 10 years old, or 9 years old and have successfully completed the SDC Taste of Sailing Opi Course and be a current member of Sutton Dinghy Club.
- 2) All applicants shall have the following swimming ability which comprises:
 - a) 25 metres swim
 - b) 2 minutes treading water
 - c) 10 seconds under water
 This may be tested and will be carried out in normal sailing clothes but without a life jacket.
- 3) Applicants are recommended to provide their own boat or to arrange a place on a boat. For those who do not have boats or a place in a boat the Club recommends that the sailor avail of a place on our Open Courses.
- 4) It is the responsibility of the boat owner/user to ensure that the boat has adequate insurance i.e. fully insured against third party and public liability claims.
- 5) Parents or adult family representatives are expected to assist in aspects of the shore-based activities of the course i.e. catering, tuck shop, slipway duty etc.
- 6) In the event of injury, parents of all trainees must accept that emergency treatment may be administered without possibility of prior consultation.
- 7) Parents/guardians of course participants give consent for photographic images to be used in information and publicity materials, and on the Sutton Dinghy Club and related websites.
- 8) Consent and waiver section of booking forms must be completed by parent/guardian.
- 9) All applicants must meet Course Prerequisites which can be viewed on the Members page at www.sdc.ie
- 10) Applicants undertake to comply with Sutton Dinghy Club's Code of Conduct. Available to view on www.sdc.ie on Policies & Procedures page
